I would like to see maybe some classes geared directly to this age group or the classes in progress now expanding the limits as far as age goes. My 14 year old daughter and I are now enrolled in the Monday night Middle Eastern dance class, but this was the only form of dance that she could consider taking as the others would not allow her until she was 16. We love the classes offered and the whole Parks and Recs system and frequently attend activities and enjoy the classes. Please consider finding activities to engage our teens in the Lawrence community as well.

Thank you for you time and consideration of this gap in the scheduling of classes for the age range 13-15.

Please, please don't cut weekend hours. Our volleyball group of hardworking old geezers, and my 16-year old daughter, have been playing Sundays in the ELC since the beginning of time (at least for Jamie and a few other of our older youngsters).

The other side of the gym is almost always very busy with basketball players. In this day and age of kids with absent parents and little physical activity, to take away one more option for wholesome, healthy activity is obscene.

Please, please, do the right thing. There have to be better, less harmful options.

Our family has used the Parks and Rec services from the time our youngest was born 2002 to the present. We have participated in many programs, classes, swimming, etc. It would be acceptable to us to have a slight fee increase - we would still keep our participation and interest level the same with a dollar or two increase per class.

Dear Parks & Recreation Administrative Office,

I will be unable to attend tonight's meeting because the very class I am concerned may be hurt by budget cuts takes place during the forum.

For several years, I have taken water aerobics classes at the Carl Knox Natatorium. I know that one of the proposed budget cuts was to close the pools at 7:00 p.m. This pool opens at 6:15 p.m. Closing it at 7:00 would mean shutting it altogether.

I really do hope that the office keeps this pool open. It serves the east side of town as well as people throughout town, and is often quite full of lap swimmers in addition to the courses that take place there. The course I attend on Tuesday and Thursday evenings is often full and has a wait list. It provides a great exercise option to people in Lawrence. I would ask that, before considering cutting the already minimal hours of this pool, the department look at other options. First, look at the costs and revenue of this pool. I think you will find that it pays for itself, particularly since the school already has to maintain the pool. If it does not, I would ask that you consider other options in order to keep it

open. One would be to open the classes to more people, thereby enhancing revenue. The classes used to have 50 attendees, then was cut to 25, now to 20. Room certainly could be made for 25-30, so that the classes would have more revenue. Fees could also be increased slightly to ensure that the classes pay for themselves.

Mr. Shaw-

I am extremely interested in the Park & Rec. issues that will be discussed at tonight's forum, however, I am unable to attend. Speaking to one on the secretaries in your office, I found out that there will be groups discussing 3 questions. I would still like to share my thoughts with you even though I can't be there tonight.

-1. Is Parks and Rec (P&R) an essential service of the city? This all boils down to what the goals are of the city. If it's to draw people to Lawrence, then having bonus features like P&R will enhance the attraction. If it's to build the mental, emotional and physical well-being of its residents, then P&R fits the bill. Is the P&R department a department providing a service for the good of the community or a department trying to make a revenue? However, during times of economic struggle (and I believe even when times are good), the amount of services or the level to which they may be offered need to be evaluated. Is it an all-or-nothing package deal? Or can we pick and choose to focus on certain activities/facilities? Possibly cutting down the number of organized classes offered would keep employee salary costs down as well as support the residents in their pursuits of saving money and not being tempted by all the options. If people really want to attend multiple aerobic/fitness classes, then the private sector should be able to satisfy that demand. Cutting down days and hours of operation would also help keep costs down. People would learn to work around these changes. Not cutting the grass as often would also help curb costs. Having the indoor pools open one day and then closed the next day when the outdoor pools are open would cut down on lifeguard costs.

Which brings me to a big issue, at least in my mind. I LOVE the South Park wading pool. It is the perfect place for my young children to play and be safe while not having to deal with the crowds at the other pools. They aren't scared because it's nice and quiet and on a much smaller scale than any of the other pools have to offer. If I had to choose between the nature center and the wading pool I'd pick the wading pool (and maybe that's what the public will have to do, prioritize what they are willing to sacrifice for). However, one thing that has always bothered me is the waste of a lifeguard that is on duty there. Every time I go to the pool, which is often, the lifeguards are just lounging under their umbrella READING or even talking on the phone! Not once have they ever appeared to be paying close attention to the safety of the toddler or children. I take that back—Once, the lifeguard told a girl she had to take the clips out of her hair. That's the only time. Whenever a kid wanders too far into the water and falls, all of us parents jump to the rescue. When someone is running around, parents are the ones to tell them to slow down. As parents, we are in the water and constantly scanning the area. I think that the lifeguard position at the South Park wading pool could easily be discontinued and replaced with a sign that there is no lifeguard on duty. The fountains could even be turned off at periods throughout the day to save on utility fees. It is little details like these that could all add up to save costs.

-2. Should user fees be increased so that taxes could be lowered? I think that the cost issue should first be addressed before deciding where to get the monies. The whole department, facilities, services, programs, etc need to be evaluated, picked through and, as I mentioned above, the little details of costs that could be reworked should be. Anywhere that pennies here and there can be cut should be. I'm sure there would be many residents interested in saving money that would volunteer their time to sit on a panel that would help critique current expenditures. I for one would be.

After reconsidering the current costs, only then would it be appropriate to make decisions on funding. Everyone likes getting something for nothing and that's what it feels like when you walk into one of the facilities without having to pay. But I only think that it is fair that people using the services should pay for the services. What taxes exactly cover P&R? If it's property taxes, then all the college students that are using the facilities but not paying those taxes are benefitting at the rest of the residents' expense. If there are people without kids, that have no interest in nature, or swimming, paying for services they won't ever use, that's not fair to them. If the fees are increased, would the city really lower the taxes to put that money back in our pockets? Or would the taxes remain the same since I'm sure it's easy to find another use for it. It also goes back to the question I posed above—Is this a department trying to make money or provide a service at cost? Because if P&R is out to make money, then it is now competing with the private sector. And if fees are increased too much more, people will go elsewhere where there are better facilities—at least in the workout facility area.

-3. What programs or facilities should P&R focus on for the future? This relates back to what your goals are. If you're going for well-rounded department then keeping the nature facility along with a pool or two and then parks throughout the city. But if the hard decisions have to be made, then I would vote for keeping the South Park wading pool open without a lifeguard—it could even stay open through September since young kids aren't in school and it's still hot out. Also, since Topeka's Gage Park already has an outdoor water park maybe Lawrence should focus on the indoor pool. Are there parts of the Nature Center that can be cleaned out or streamlines to cut costs and focus on more specialized areas? Do we really need both the fields at the Sports Complex AND the fields at Holcomb Park to be maintained if there are also school fields that can be used? While it's very convenient having so many nice, small parks throughout many neighborhoods of the city, is it really necessary? I think it's great that there are exercise facilities where families can go together and kids can learn to be excited about keeping their bodies strong and healthy.

As the parent of a 14 year old son I am disappointed at the lack of programs offered for youth of that age through the Parks and Recreation Department. Most of your youth programs have an age cut-off at 12 or 13 and the adult programs require them to be at least 16 years of age. Out of all the programs in your catalog there appear to be 2 that he would be able to take. Youth sports? Forget it, those appear to end in elementary school. Lest you are tempted to rationalize your total lack of support for these programs by saying they are available through school let me point out that at Southwest Middle School I counted nearly 60 boys at the informational meeting for basketball. Only 10-15

boys were selected for the team and there are no intramural sports available in the middle schools.

These kids are too young for employment and at an age where they are certain to take unhealthy risks if left unsupervised for long periods of time. (The young boys in our neighborhood occupy themselves chasing each other with "air soft" guns during the summer days.)

With the push on getting kids outside and on exercising and developing a health lifestyle you appear to have abandoned an entire age/gender group from your goals. Frankly, I expect better.

I won't be at the meeting tonight but wanted to share my thoughts.

I consider Parks and Rec to be very important to kids in town. I played sports through parks and rec as a kid and took swimming lessons, and it was a great experience for me. The lack of softball and baseball fields concerns me. Here are my suggestions.

Add a small fee to each player's regular fee (\$1 to \$5) to play tball/baseball/softball, which will be used ONLY for creating playing fields/repairing lights, etc., and will be collected ONLY until the specific goals, which have been presented in writing, are fulfilled. I do not want to pay more taxes, and don't think people without kids playing ball should have to support this, but as a parent whose kids are playing tball and softball, I would be willing to pay an additional fee to ensure enough fields are in town.

What about the practice fields around town that are in disuse? The two that come to mind are the backstop SE of the large shelter at Broken Arrow, and the

backstop at Prairie Park. I assume it would be less expensive to equip these fields and others like them around town for games than it would be to build a new complex? I would like to hear discussion of options like this.

As for instructional classes for kids, I have always chosen Parks and Rec classes over private facilities (like with tumbling), since the Parks and Recs classes are less intense and less costly, and my kids are just experiencing things and not pursuing Olympic dreams. If the costs are raised so much that they are comparable to a private facility, however, I would likely pay for the private facility instead of Parks and Rec.

I have worked out a few times at the Parks and Rec facilities. I would possibly pay a nominal fee to work out, but likely would not. Thank you for your time! Paige Marett

I hear there is to be a public forum on cutting costs for parks and rec... Here are a few thoughts since I can\'t attend.

Tell them to raise the fees. People who love the programs will pay a marginally higher fee for them. I\'d rather pay than not have them at all. At least we\'d have the option, then.

Events like the frisbee competition, etc., are what make Lawrence the charming town it is. We\'ll pay to keep it that way. And I\'m poor - and I\'ll still pay. :)

I attended last night's meeting at Lawrence High School but forgot to leave my email address. I'm Bill Dentler at wdent@ku.edu. I came in support of the City Band Concerts, which I feel are a unique and special part of Lawrence with a history dating back to the Civil War. I strongly feel they should be supported, particularly because, unlike many athletic facilities, there is little maintenance or other long-terms costs associated with the program.

I do have a question about Eagle Bend. I'm not a golfer, although I did play a bit for a few years, but noticed that you said that Eagle Bend actually pays for itself. According to my notes, it requires \$816.629 (08) and returned \$ 918,202, which, in my mind, makes it a fine example of a facility that pays for itself.

However, I also note that there is a "debt service" of \$305,000 that will continue until 2016. I may have written this down wrong, so please correct me, but does this mean that there is a total of \$305,000 debt or that the Department must pay \$305,000 each year until 2016. If this is the case, then Eagle Bend is extremely expensive, and does not come close to paying for itself. If this is the case, then it is not such a "fine example" and, clearly, fees for use should clearly be raised until the place is paid off.

I'm just trying to figure this out for myself and would appreciate any corrections you might have.

Otherwise - I appreciate the meeting last night. I've lived here for 30 years and often take many of the fine Lawrence features for granted. When I have more time, I certainly will pay more attention to the need for volunteers and will do so.

Thank you for seeking public in-put on recreational issue for the future. Just now much emphasis is put on fitness, so eliminating any programs which encourage activity would be a mistake, as would increasing fees for such activities. Perhaps downtown merchants can pick up their beautification projects (as do places like McDonald's) and others can be curtailed or eliminated. Purchase of new equipment can, of course, be delayed. And, since both pools are on the north end of town for the summer season, equity would require that the Carl Knox pool be kept open as much as possible, and as many programs/lessons be offered there as possible. We in Lawrence value our parks and recreational opportunities and a tax increase just for that purpose would be supported by many as an alternative to cuts or increases in fees. To Whom It May Concern – I have been coaching youth baseball in Lawrence now for 8 years. Each year it becomes increasingly more difficult to gain access to facilities to hold practice. My teams have finished either first or second in their respective league every

year winning at least 85% of our games in Lawrence. With that said, when we travel outside of Lawrence to play, our record against our opponents drops dramatically to 50% at best. I believe this can be attributed directly to the lack of adequate developmental facilities in Lawrence for youth baseball. Our teams simply cannot compete against teams from neighboring cities who have facilities readily available to them not just during baseball season but year round as well. Lawrence cannot even keep up with the demand for facilities during the fair weather months.

My teams play a competitive brand of baseball and my knowledge of how baseball works in Lawrence does help gain access to facilities. However, I can't imagine what it would be like for someone who does not have that knowledge and experience and is trying to put a team of kids together to learn the game of baseball. My guess is there are a significant number of kids and coaches who simply choose not to participate out of frustration. From my point of view, the lack of adequate facilities is simply suffocating the great sport of baseball in our city. In Lawrence, the sport of baseball is rapidly becoming available to only a select few who have access to the scarce facility resources offered by our city. I understand the financial problems our city must be facing and the demand on limited public resources. I run financial operations for 11 hospitals so I am no stranger to financial challenges. As such, I know there are multiple options to solving problems. I do not believe throwing public money at this is the only solution. There is a great deal of private interest in improving baseball facilities in Lawrence. If the city is unable to fully support an initiative to improve facilities, perhaps some sort of a partnership arrangement with the private sector could be considered. Baseball should be the most inclusive youth sport in Lawrence. If we do not come up with a solution soon, it will become the most exclusive, only available to the chosen few. Sincerely, Scott Pester
