While it is not possible for us to attend the meeting, we would like to voice our concern and request to deny that request. As you know the traffic on Louisiana can be very busy at times. Our driveway faces Louisiana street and there are times when we actually sit there 10 to 15 minutes to back out of the driveway. Needless to say it is quite frustrating. The way the lights are situated on 23rd, the constant cars coming and going from Checkers and the Malls Shopping Center there is no good time to get out of the driveway. We park our vehicles on our side of the street (the North side of Dakota) in front of our house and it makes leaving easier because we just leave from the stop sign. I respectfully request that the Commission consider my request to limit parking on Dakota from Louisiana to Ohio to one side of the street. The reason for the request is that the street is not wide enough to allow more than one vehicle to pass when cars are passed on both sides of the street. The requested block provides the closest access to the 23rd and Louisiana intersection from the Parkhill neighborhood and is heavily used by neighbors wanting to travel out of the neighborhood avoid 23rd Street. Drivers pull off of Louisiana into the neighborhood and often find that they have to stop at the corner of Dakota and Louisiana and allow another car to pass. When cars park on both sides of Dakota, visibility is drastically reduced, and there is no longer room for two-way traffic. This becomes especially hazardous when cars are trying to turn onto Dakota from Louisiana while cars are also leaving the Park Hill neighborhood via Dakota street.
