I respectfully request that you approve the request to revise the Preliminary Development Plan, PDP-14-00183, to meet the parking requirements of the project and consider approving the original request to eliminate 100 parking spaces from the development.

Dear Mike:

I would like to express my strong objection to excusing the developers of the proposed Indiana Street apartment complex from providing adequate parking on-site for their tenants. I am writing because believe that the Lawrence City Commission needs to hear about the parking situation on campus from someone with firsthand parking experience. I regularly (6 days each week) park in the lots being affected by the proposed arrangement with the University. Teaming up with KU to require 100 of the tenants to park in University parking lots does not ameliorate the parking problem in the Oread neighborhood, it just creates additional problems exacerbating the difficulties of parking in the area.

The two University parking lots in the area are often filled to capacity already. The University lots are expensive and many students and visitors choose to park along the streets. Unfortunately, there are not enough parking places in the two lots and along the streets and relatively close to campus to accommodate the current students and staff. If the tenants of the newly proposed housing complex purchased long-term parking passes in the lot, there would just be increased difficulties for students, staff, and visitors.

The museums on the north end of campus already suffer from inadequate parking. The Spencer Museum of Art lost hundreds parking spaces a few years ago when the parking lot to the north of the building was converted to a football practice field. Complicating that, they also lost needed swing space for buses and large trucks making deliveries. There truly is now inadequate parking for museum visitors close by.

During home football games, all vehicles with paid passes to use the University parking lots there on the north side of campus are required to remove their vehicles so that football parking can be accommodated. Forcing the 100 vehicles that are from the apartment complex to park on the streets will exacerbate parking for visitors and staff on those days. It is already very difficult for staff to find parking on football Saturdays.

Converting the parking along Mississippi Street to metered parking is a very poor choice for staff and students. Those spots fill well before 8:00 A.M., despite being a considerable distance from the buildings where folks work. These parking spots fill so quickly in the mornings that they are unavailable for students or visitors to campus.

I urge the City to reject the proposal to use KU parking spaces to accommodate residents in the newly proposed Indiana Street apartments. Parking in the Oread neighborhood affects hundreds of people, including neighborhood residents, university students and staff, and visitors to the area. The proposal before the Commission will truly exacerbate the already-difficult parking situation. Please feel free to share this letter with others on the Commission.

It illustrates how KU parking at GSP and Corbin is overflowing onto Oread streets, across the street from the proposed HERE development. My view is the overflow will just become worse from KU alone, much less the addition of HERE overflow.

Hi Kyle – I'm so sorry I completely spaced this out. Yes, you're right, GSP/Corbin permits are oversold (actually, all categories of permits on campus are oversold). There are 307 spaces available for this parking permit. We've sold 373 of these parking permits. Overflow parking for these permits is lot 94 on the east side of the stadium. I do believe that residents would rather try to find parking on nearby city streets than to park at the stadium.

It is my hope next year to keep a waiting list for parking for these residence halls and not oversell — overflow parking would only be offered at the west campus park & ride lots and we'd offer 24-7 transit back to the residence halls. This has not been approved at this point. I'm afraid the result might be that residents who don't get a permit for the proximate lots will choose to park on the city streets without any permit.

I took part in a study the city conducted about parking in the Oread neighborhood. The report recommended some kind of parking permit system there too but I'm not sure where the city stands on this. Luckily, it looks like HERE@KS will have to provide all of the requisite parking for their project.
