Mr. Cronin,

Early in the year I attended a meeting at Langston Hughes Elementary to discuss citizen concerns about the Bob Billings K10 Exit. We were asked to represent our concerns on large posters, placing a push pin at a site on Bob Billings that expressed our concerns for safety and access. My home is on the south side of Bob Billings and I use Bob White to exit the neighborhood both by car and on foot. I pushed my pin along with many others to note to those who are planning and don't live in our neighborhood our wisdom about what is needed to make a bad situation (exploding traffic) better.

I took a walk today. The K10 Exit is not open. I had difficulty at 9 AM (after school and business traffic) crossing Bob Billings to walk into DeVictor Park. I am extremely concerned about the traffic as it gains speed going east after the George Williams light. By the time it rounds the curve, cars are exceeding 40 mph. At Bob White there is a grade that allows the traffic to speed up more. By the time the traffic is at the bottom of the hill going east I believe that most traffic is going 50 to 60 miles an hour. I anticipate that turning left into my neighborhood at peak traffic hours will become hazardous at the Bob White intersection. I expect to be hearing crashes and ambulances at that intersection when the Exit is opened.

I believe in progress. But I do not believe in progress that impedes the safety of citizens. I ask that you reconsider your safety planning for the Bob Billings K10 access, placing a traffic light at Bob White.

It is astonishing to me that no mention is made of the intersections of Foxfire Drive and Bob Billings Parkway, and of Research Park Drive and Bob Billings Parkway in the discussion of the segment from K-10 to Wakarusa. Sight distance and the difficulty for northbound traffic to make a left turn from Foxfire onto BBP are problems that neighbors in the area have presented to staff on numerous occasions. Increased traffic from the opening of the K-10 interchange will only exacerbate this situation and others problems along this segment of BBP.

It is inexplicable that the average speed on this segment (55 mph) is not mentioned in the report because controlling that speed was the top priority at all the neighborhood meetings with staff. Yet nothing is recommended to reduce it. Why is this? At least one roundabout or signal should interrupt drivers along this segment in order to control the speeding, to provide traffic gaps to facilitate turns and to offer pedestrians an opportunity to cross this busy traffic artery with safety. It is extremely disappointing that the city traffic engineers are willing to ignore warrant standards along other segments of BBP in order to provide for a safer street, but seemingly have no concern about worse situations along the segment from Wakarusa to K–10. I hope the city commission will not allow these staff recommendations to go unchallenged.

Considering the fact that Bob Billings Interchange will be completed in December, we are very concern with the safety of roads, crossing to the DeVictor Park, bike riding, and even walking in the sidewalks.

We had hoped that the City would improve the safety of traffic in the Bob Billings Parkway when contractors where working on the the roads over the summer though nothing has changed for us who live in the Bob White area.
