### **CONDITIONS OF APPROVAL**

- a. A 20 foot clear fire access path must be provided around the building to the temporary fence located on the north side of the building.
- b. Access to the front of the building may not be blocked
- c. The Special Event Permit must be displayed on site during hours of operation.
- d. Temporary sign permit must be obtained from Development Services for proposed temporary signage.
- e. Any structures must be removed within 24 hours after the cessation of the event.
- f. No structures or display areas may be located within 25 feet of the W. 6<sup>th</sup> Street right-of-way.
- g. The applicant shall provide trash receptacles or other sanitation provisions as needed
- h. Cars, trucks, vans, or trailers may not be used for sale of merchandise.

#### i. If tents or awnings are used for this event:

- a. Tents must be certified flame retardant. (label on tent or paperwork available for inspection).
- b. 2A1OBC portable fire extinguisher must be provided.
- c. "No Smoking" signs must be posted and enforced.
- d. No open flame within the tent.
- e. Per Fire Code, tents over 200 sq. ft. must be located further than 20 feet from buildings or structures.
