# 3. <u>Consider adopting on first reading, Ordinance No. 9305, pertaining to the licensing and regulation of massage therapy businesses within the City of Lawrence, as requested by the District Attorney's office.</u>

**Moved by Vice Mayor Boley** to defer regular agenda item 3. Motion died for lack of a second.

Greg Pruett, Detective Lawrence Kansas Police Department, and Maria Garcia, Assistant City Attorney, presented the staff report.

The City Commission directed staff to schedule a joint City/County work session to discuss the licensing and regulation of massage therapy businesses for the purpose of obtaining input from the County, the District Attorney and additional input from the massage therapy community.

**Moved by Mayor Soden, seconded by Commissioner Herbert,** to find that the proximity of the temporary sale of alcoholic liquor is not adverse to the public welfare or safety and grant a distance limitation waiver. Adopt on first reading Ordinance No. 9332 allowing the sale, possession and consumption of alcohol on the public right-of-way on the 100 block of east 8<sup>th</sup> Street, and the 900 block of New Hampshire Street during the Buskerfest event. Motion carried unanimously.

#### 2. <u>Conduct a public hearing regarding a distance limitation waiver request for the</u> 2017 Art Tougeau Parade and Final Friday Event to be held on Friday May 26, 2017 from 9:00 a.m. to 11:59 p.m. The public hearing would apply to the 900 block of New Hampshire Street portion of the event.

**Moved by Commissioner Amyx, seconded by Commissioner Herbert**, to open the public hearing. Motion carried unanimously.

**Moved by Commissioner Herbert, seconded by Vice Mayor Boley,** to close the public hearing. Motion carried unanimously.

**Moved by Vice Mayor Boley, seconded by Commissioner Herbert**, to find that the proximity of the temporary sale of alcoholic liquor for the event is not adverse to the public welfare or safety and grant a distance limitation waiver. Adopt on first reading Ordinance No. 9333 allowing the sale, possession and consumption of alcohol on the public right-of-way on the 900 block of New Hampshire Street during the Art Tougeau event. Motion carried unanimously.

# 4. <u>Consider adopting the City of Lawrence strategic plan and priority initiatives.</u>

**Moved by Mayor Soden, seconded by Commissioner Herbert,** to adopt the City of Lawrence strategic plan and priority initiatives. Motion carried unanimously.

#### 5. <u>Consider recommendations related to requests for additional protections for</u> <u>marginalized groups.</u>

Casey Toomay, Assistant City Manager, presented the staff report.

**Moved by Commissioner Herbert, seconded by Commissioner Larsen,** to proclaim the City of Lawrence a welcoming city and include 'immigration and refugee status' in the proclamation; authorize the Mayor to co-sign a letter, along with student body presidents from Haskell and KU, encouraging our federal delegation to uphold protections for marginalized groups; draft a letter encouraging The University of Kansas to consider expanding legal resources for students and potentially non-students looking for legal advice related to immigration issues; direct staff to work with the University of Kansas to co-sponsor a community presentation on immigration law; authorize staff to write letters of opposition of pending state legislation; and, authorize staff to reach out to interested agencies to discuss the City's position on these issues. Motion carried unanimously.
