Bert Nash Community Mental Health Center 2007 Funding Request to City of Lawrence Supplemental Information

- 1. The Bert Nash Center is funded through three main sources; fees for service, state and federal grants and Douglas County support.
 - a. The Fee for Service revenue accounts for approximately 50% of our resources and represents billable services to payer sources such as Medicaid, Medicare, commercial insurance and client's ability fees.
 - b. The state requires the Center to provide mental health services to individuals with severe and persistent mental illness and children with severe emotional disturbance that reside in Douglas County. The state provides grant funding and state aid in support of mental health services to these populations since the service is provided without regards to any ability to pay.
 - c. In addition the Center receives state and federal grant funding for supportive housing and supportive employment programs that serve the needs of clients with mental illness.
 - d. One of the vital programs for youth is WRAP (Working to Recognize Alternative Possibilities) which has been funded through USD 497 by a federal grant, City of Lawrence Alcohol funds, Baldwin & Eudora School Districts.
 - e. The Center contracts with USD 497, Douglas County Sheriff and Lawrence Memorial Hospital to provide mental health screening, counseling and evaluation services.
 - f. Douglas County provides funding from general appropriations in support of the Centers services to resident of the County. These funds are utilized to support staff and supplement services to populations with no resources for payment.
- 2. The Bert Nash center employs a staff of 187: 137 full time and 50 part time. The 2006 Budget is as follows:
