Description/Justification:

Douglas County CASA, Inc. provides a unique and economical service to the community. CASA recruits, trains and supervises community volunteers that work with children who have been abused and/or neglected and are in the court system through no fault of their own. The children that CASA workers are assigned to are among our most vulnerable citizens and often have multiple, complex problems resulting from the abuse that they have endured. They require the specialized attention that a CASA can provide to make sure that they do not "slip through the cracks" of the system. CASAs can help ensure that all their needs are met and work to help them find a safe, permanent home in a timely manner.

CASAs have four main responsibilities: 1) Complete an independent examination of the child's situation by interviewing parents, foster parents, therapists, teachers, doctors, social workers, etc. 2) Identify resources and services for the child and facilitates a collaborative relationship between all parties on the case, helping to create a situation in which the child's needs can be met. 3) Advocate for the child's best interests by making recommendations to the judge about where the child should live, services needed, etc. At the same time, the volunteer presents the child's wishes and thoughts to the court. 4) Monitors court ordered services to ensure that progress is being made.

In 2005, 80 **NEW** children entered the foster care system in Douglas County. We were able serve 48 of those children, and also continue serving 60 children whom we had already been serving in 2004. Unfortunately, that still left 32 new children who entered the system without a CASA volunteer in addition to those children whom we have just not ever been able to serve. There continues to be a great need for CASA.

2. Total budget for the agency, number of personnel, and how the funding would be used.

The total projected budget for fiscal year 2007 is **\$142,443.** Program staff currently includes one full-time Executive Director, one 32-hr. part-time Administrative Assistant, one 20-hr. part-time Volunteer Supervisor, one 24-hr. part-time Volunteer Supervisor and one 28-hr. part-time Volunteer Supervisor. It is anticipated that in 2007, staffing will include one full-time Executive Director, one 32-hr Administrative Assistant, one 20-hr part-time Volunteer Supervisor, one 24-hr part-time Volunteer Supervisor, one 30-hr part-time Volunteer Supervisor and 1 Contracted PRN Volunteer Supervisor to assist with case overflow.

City of Lawrence funds for 2007 will be used to recruit and train new volunteers, provide on-going training and supervision to existing volunteers and to increase community awareness of the program and the issues related to abuse and neglect.
