### **New Initiatives/Programs:**

No new programs are anticipated for 2007. Our goal is to continue maintaining the high level of services currently being provided.

#### **Revenue Related Issues:**

In 2005, the Society's Board of Directors was successful in raising the funds needed to pay off the \$200,000 capital loan taken for construction of the Linda K. Watrak Stray Intake Center. By paying off this loan, the monies used for interest payments are now available for operational costs.

We continue to hope for successful fundraising events in the future. Our annual appeal to the community raised \$85,000, which allowed us to stay within our operational budget through the end of 2005. We received a \$35,000 Rice Foundation grant in 2005, which provided \$25,000 for the capital loan and \$10,000 for operational expenses. We also received a \$27,000 grant from the Kriz Foundation for building repairs. In addition, we received a bequest for Erma Whitsitt for \$42,000. We continue to search for new sources of funding, submitting 10-15 grant proposals each year to various humane, corporate and community organizations.

We are having difficulties in having animal issues (cruelty/neglect, dangerous/viscous) properly processed through the court systems. Due to the slow action of governmental officials on various levels, we find ourselves in the position of having to house and care for animals for indefinite periods of time. Some animals have been held for almost two years awaiting some type of action by local law enforcement and/or the court system. We hold and care for these animals as a service to our community, but also because we can provide these animals with the first "real" and humane care in their lives. However holding these animals indefinitely places a strain on the Society's financial resources and staff. It also places an immense strain on the animals themselves. The Society hopes that these cases can be expedited with the help of our local elected officials and law enforcement agencies. Without such help, the Society may have to request additional funds in future budget requests for the care of these animals.

### Description/Justification for 2007 Outside Agency Funding Request

The Lawrence Humane Society, Inc. operates the Ise Memorial Animal Shelter and Linda K. Watrak Stray Facility for the benefit of citizens in the City of Lawrence and surrounding Douglas County. The Society is requesting funding for providing the following services:

- A. Assist in enforcement of City ordinances regarding impoundment of animals found running at large by:
  - 1) Receiving animals from the City Animal Control. House and care for the animals for 3 business days or until they are reclaimed, as space and State regulations allow.
  - 2) After 3 business days, take permanent ownership of any unclaimed animal for the purpose of adoption or humane euthanasia.
  - 3) Provide assistance to Animal Control Officers in identification and prosecution of violators.
- B. Assist in receiving and investigating complaints of cruelty and neglect to animals, including assistance in prosecution and boarding of seized animals upon request and accompanied by the Lawrence, Kansas, Police Department.
- C. 24-hour, 7 days-a-week pick-up, board, veterinary care of injured, un-owned companion animals.
