E. If you are requesting an increase in funding over 2008, please explain exactly how the additional funds will be used: In 2007, BCS was provided \$7200.00 for the Emergency Service Council. Each month, the agencies that utilize this funding receive many requests beyond what the existing budget will allow. ESC is only able to provide funding for as few as 15% of those households who seek assistance. More funding will allow ESC to help more people. Persons who do not find funding in these emergencies face eviction, and loss of utilities which can in turn lead to greater financial loss and eviction. With the City's concerns about fighting homelessness, giving priority to homelessness prevention is paramount.

# Section 4. Statement of Problem/Need to Be Addressed By Program

A. Provide a brief statement of the problem or need your agency proposes to address with the requested funding and/or the impact of not funding this program. The problem that the Emergency Service Council (ESC) addresses for the city is prevention of homelessness and poverty in the face of a worldwide economic crisis. ESC has provided emergency funding for families and individuals in need for nearly three decades. Many families experience financial difficulties that can be stabilized with a small amount of help. Without this funding, loss of residence or utility can lead to much greater difficulty including homelessness. The Emergency Service Council was able to assist 832 individuals with ESC in 2007. However, the need is growing with rising retail costs, fuel costs and with many labor jobs affected by the slow housing market.

In 2007, the Ballard Community Center launched a research tool to study the efficacy of ESC assistance that indicates ESC funding not only provides the necessary immediate help, but provides a level of stability needed for families to maintain housing and utility services independently.

B. How was the need for this program determined?

The necessity of this program to Lawrence area citizens is determined historically and by the ongoing requests for assistance. In the past thirty years, there has been consistent need for financial assistance by persons living in Lawrence. This continues today with numerous households reaching out for help, many of which cannot be helped due to lack of funds.

After contacting Power, Gas and Water companies in the area, we have found that the number of pending utility disruptions outpace the monthly funding budget by hundreds of households. In addition, in 2007, ESC provided funding to 327 families who needed rent assistance.

Lawrence Area Citizens are finding it harder to buy the things they need because prices are increasing. According to the Energy Information Administration, the agency that produces statistical information on Energy Issues, Midwestern gas prices have gone up by \$.69 per gallon since April of 2007. In the last three weeks, gas prices have risen in the Midwest by \$.11. These prices affect retail goods and services as shipping and production costs are going up. According to the Wall Street Journal (online edition, 4.19.08) even as taxes have been lowered, increasing prices have driven disposable income in the middle class to nearly 0% nationwide. In addition, food inflation has reached a record high of 4% in 2007 and this trend shows no sign of abating. With rising costs of food, low income families will have increasing difficulty providing basic human needs for survival.

C. Why should this problem/need be addressed by the City?

The 2005 Lawrence Task Force on Homelessness report, noted that 112 homeless adults had been counted in a census of homeless individuals. Of these, four families with children were included. 23 reported having their children with them. Another 40 children were noted as being part of the family unit but were not homeless, which indicates family separation due to homelessness. Of these, 53 adult respondents noted inability to afford rent, eviction for non-payment or eviction for another reason. 67 respondents also noted loss of employment or loss of income as a factor in their homelessness. The Emergency Service Council endeavors to keep these numbers from growing and, with increased funding, can possibly decrease the potential number of homeless persons in Lawrence. The City has pledged its commitment to reducing homelessness. Where treatment of homeless individuals and families is a high priority, prevention is the key to avoid a flood of new homeless in the wake of the current economic environment.

# **Section 4. Description of Program Services**

ESC serves Douglas County residents who are certified as low income. Households that include children, elderly and/or persons with disabilities are to be given priority. Persons outside of these demographics are also provided services when funds are available. We provide a maximum of

\$200.00 toward past due rent or utility charges. ESC can also provide funding for rent or utility deposits for persons who are seeking new housing. No more than \$200.00 can be approved for any household within a 12 month period. ESC monitors household usage with a secure website that tracks spending and client information. This website is updated twice per month. In 2007, 832 individual clients were served in Douglas County of which over 750 were Lawrence residents. Based on a comparison of individuals served in the first quarter of 2007 and the first quarter 2008, there has been a 21% increase in approved applicants. This is reflective of increases noted in requests for assistance in other BCS programs in the past five years.

B. Describe any efforts your agency has made to explore the community to determine if there are any other agencies providing similar types of services. What efforts have you made to coordination services?

Ballard Community Services and all of the participating ESC agencies (ECKAN, DCSS, WTCS and Salvation Army) meet quarterly to discuss progress and improvement of the ESC program but also discuss and explore other funding in the area. It is common that ESC funding is not enough to help a household, so ESC members routinely communicate with other area agencies, churches and civic groups searching for alternative funding. ESC agencies are commonly approached by other agencies as well to work as a team to help a family. This community teamwork is an important ingredient in the success of the Lawrence residents we serve.

The ESC member agencies endeavor to provide other services to enhance the financial services provided. For example, Ballard Community Services is partnering with Douglas County Housing and Credit Counseling, US Bank and United Way to provide a financial planning seminar called "Debt Self Defense." This will be open to the public but persons who are receiving services are strongly recommended to attend.

# Section 5. Program Objectives

### **Program Objectives**

- 1. Immediate Outcomes: Client is able to stay at residence or the client's utilities were not turned off for 30 days: Target 50%
- 2. Intermediate Outcomes: Client Maintained residence and/or utilities were not shut off. Target 50% and client is able to maintain employment: Target 40%.

3. Long Range Outcomes: Client remains at permanent residence. Target 40%. Client is able to increase assets (house, car, save money) Target 5%. Household members are able to continue education and gain higher education: Target 5%.
