Yes, JAAA received \$7830 last year from the General Fund.

E. If you are requesting an increase in funding over 2008, please explain exactly how the additional funds will be used:

In May of 2007, Centers for Medicare and Medicaid informed the Kansas Department on Aging that Area Agency's on Aging would no longer be paid for travel time to and from clients' homes. Using actual FY 2007 travel time, this change in policy could cost JAAA approximately \$10,000 in Douglas County alone. JAAA believes it is vital that case managers go to the homes of the frail and elderly of our community to ensure their continued independent living.

These additional funds will allow JAAA's three FTE case managers housed in Lawrence to continue to access the senior population in their homes. It is important to assess them in their home environment to get the full picture of the senior's needs. The case managers will be able to continue to visit seniors in their homes to coordinate their in-home services care plans (such as homemaker assistance, bathing assistance, personal emergency response monitoring, etc.) and assist with Medicare Part D, Homestead tax assistance, Low Income Energy Assistance Program (LIEAP), informing seniors about the federal tax rebate, informing and assisting seniors with digital TV changes. In general keeping Lawrence seniors who have difficulty leaving their homes and accessing community services, informed of all benefits available to them.

According to the Bureau of Labor Statistics, consumer prices increased 4.1% in 2007, and have increased another 3.1% through March of 2008. Jayhawk Area Agency on Aging is asking for a 5% increase from its 2008 City of Lawrence support to maintain our quality of services to seniors.

## Section 4. Statement of Problem/Need to Be Addressed By Program

A. Provide a brief statement of the problem or need your agency proposes to address with the requested funding and/or the impact of not funding this program. During FY 2007, JAAA allocated over \$1.4 million of state and federal funds for services to seniors in our three county area. Service providers include not-for-profit agencies, county agencies and private home health agencies. These agencies provided clients assistance with personal care, homemaking, meals, personal emergency response monitoring, respite care, legal assistance, caregiver support and transportation. In 2008, Jayhawk Area Agency on Aging allocated approximately \$340,000 in Older Americans Act grant awards to six agencies who serve in Douglas County. If current needs for services continue, another \$87,188 in Senior Care Act services will be provided to Douglas County residents through five agencies. Although we do not have access to the dollar value of services provided, JAAA is currently coordinating in-home services for an additional 98 Douglas County residents through Medicaid Home and Community Base Services, delaying their nursing home admittance. To serve Douglas County, JAAA rents two offices at the Douglas County United Way Building, employing 3 FTE case managers receiving salary and benefits of \$81,000.

Jayhawk Area Agency on Aging funded services for 8676 individuals in fiscal year 2007. 20% resided in Douglas County. Of those Douglas county residents served, 23% were low income; 17% lived alone and 48% were aged 75 or over. According to the Governor's Economic and Demographic Reports, 24% of the aging population in our three county Planning Service Area resides in Douglas County. Douglas County has been awarded 27.4% of JAAA's 2008 Older Americans Act dollars. The remaining programs Jayhawk Area Agency on Aging manages are based on consumer need, consumer choice, and eligibility, and we cannot break down by city or county how the service dollars are distributed.

If the City of Lawrence did not fund these programs, Jayhawk Area Agency on Aging case managers will have to significantly reduce the number of times they are able to monitor the living conditions of their clients, possibly missing potentially dangerous situations.

B. How was the need for this program determined?

State and Federal funds continue to remain stagnant. A Baby Boomer turns 60 every seven seconds, while the fastest growing segment of our population is the 85 and older age group. The population JAAA serves continues to grow and the agency is committed to assisting these persons in our tricounty area. The demographics are too startling for an aging agency to later play catch-up with its funding.

C. Why should this problem/need be addressed by the City?

Although JAAA does not keep agency-wide demographic statistics by city, 75% of the Douglas County residents served directly by JAAA case managers, have an address in Lawrence.

Keeping seniors in their homes helps sustain the economic base of the City of Lawrence and their incomes continue to be spent at Lawrence businesses.

The role of Jayhawk Area Agency on Aging (JAAA) is to enable seniors within Douglas, Jefferson, and Shawnee counties to maintain their independence and dignity. JAAA is both a provider of resources and a provider of services. The services JAAA provides directly to seniors includes information, outreach, case management, caregiver support and insurance counseling to Medicare beneficiaries.

JAAA expects to serve at least 8600 individuals in 2009, with at least 1800 of those residing in Lawrence/Douglas County area.

B. Describe any efforts your agency has made to explore the community to determine if there are any other agencies providing similar types of services. What efforts have you made to coordination services?

A JAAA staff person attends Interagency Network for Aging (INFA) meetings regularly at the Lawrence-Douglas County Health Department to coordinate the needs and services of seniors of Lawrence and Douglas County. Another JAAA staff person is involved with the Douglas County Advocacy group. JAAA is also represented monthly at Lawrence Area Partners in Aging (LAPA), Older Women's League and the new Douglas County Coalition on Aging. JAAA is also planning to develop an elder abuse coalition and hoarding coalition during FY '09 in Douglas County.
