- I. CALL MEETING TO ORDER: Determine quorum of members. 5:35 p.m.
- II. Approve May and July meeting minutes. Motion by Michael Steinle, second by Rachel Krause. Approved.
- III. SAB Administration
 - a. Introduction of Kay Johnson, newly appointed member of SAB.
- IV. Discussion: City Commission, August 13 meeting and receipt of SAB recommendation
 - a. On August 13, the City Commission received a recommendation from the Sustainability Advisory Board to implement a \$0.16 fee for plastic and paper bags at retail locations in an effort to reduce waste. Commission agenda materials here:

 - Commission was receptive to the proposal and all expressed support for either a
 fee or a ban. There were several comments from Commissioners expressing
 appreciation for the collaboration with KU on this issue.
 - c. Staff will meet in early September to discuss research, including the alternatives of fee and ban, with the intent of bringing back something to the City Commission before the end of the year.
 - d. Based on the research questions, staff will connect with other communities who have successfully implemented fee/ban.

V. Subcommittee report

- a. 100% renewable recommendation in development.
- Food Policy Council and SAB joint committee on food waste (FORWARD): Food Waste Toolkit for restaurants in coordination with the Lawrence Restaurant Association, will be rolled out during Restaurant Week.
- c. Subcommittee structure: some members are frustrated with subcommittee communication. Communication tools are limited between Sustainability Advisory Board members because they are subject to the <u>Kansas Open Records Act</u>. The recommendation is that subcommittees establish ground rules that take into consideration availability of members, meeting schedule, and communication expectations.
- d. Format of subcommittee reports: Subcommittee reports should include progress updates. One available tool is the 90/90 tool, which provides a template for a 90-day action plan.

VI. Staff Report

- a. The City Commission approved the 2020 Budget on August 13, which included funding for Climate Planning.
- b. Sustainability Office is in the process of hiring a Sustainability and Food System Analyst
- c. Sustainability Fellowship: Draft of greenhouse gas inventory technical report will be done next month.
- d. Working on a solar feasibility analysis with <u>NASA DEVELOP National Program</u> to identify buildings with high performance potential for rooftop solar and land ideal for ground mounted solar. Results will be available this fall.
- e. Upcoming events of interest

 - Drawdown Workshop, Tuesday, August 27, 5:30-7:30 p.m.
