## **Maple Ln and 19<sup>th</sup> St. Improvements Project Fact Sheet**

### **PROJECT DESCRIPTION**

The City is beginning work on the Maple Ln. and 19<sup>th</sup> St. project which may impact your property, residence, or neighborhood. The project includes the following work:

- **Asphalt milling, patching, overlay, concrete pavement and curbs rehabilitation**
  - Maple Ln. north of 19<sup>th</sup> St., and 19<sup>th</sup> St. from Almira Ave. to Harper St.
- **Storm sewer improvements**
  - Maple Ln. north of 19<sup>th</sup> St., 19<sup>th</sup> St. from Maple Ln. to Harper St., and at the entrances of E. 18<sup>th</sup> Terrace, E. 18<sup>th</sup> St., E. Glenn Drive, Miller Dr., and Brook St.
- **Replacement of an existing waterline**
  - Maple Ln. north of 19<sup>th</sup> St., and 19<sup>th</sup> St. from Maple Ln. to Harper St.
- **Sanitary sewer improvements**
  - Maple Ln. from 19<sup>th</sup> St. to E. 18<sup>th</sup> St., along Clare Rd. to 19<sup>th</sup> St., and along 19<sup>th</sup> St. to Maple Ln.
- **Sidewalk and ADA accessibility improvements**
  - At the Park entrance off of Maple Ln., at the intersection of Maple Ln and 19<sup>th</sup> St., along 19<sup>th</sup> St. from Maple Ln.
- **New Bus Stop**
  - Near the intersections of 19<sup>th</sup> St. and Harper St.

### **PROJECT TIME FRAME**

The City anticipates construction to **begin Late 2024** and **conclude in the Summer of 2026**. These dates are subject to change due to weather or other construction-related delays.

### **ANTICIPATED TRAFFIC IMPACTS**

Over the course of the project, there will be temporary traffic restrictions at various locations along Maple Ln. and 19<sup>th</sup> St between Almira Ave. and Harper St. Construction activities and traffic control will be sequenced to minimize disruption and will not all be performed at one time.

When this project begins in Late 2024 (pending weather or other delays), contractors will start with a closure of Maple Ln. from the Edgewood Park entrance to E. Glenn Dr.

### ***How may this impact my neighborhood?***

You may see increased traffic in your neighborhood as drivers adjust to the new closures. The City will continue to update signage and communication as needed, and we appreciate your patience and understanding during this construction process.
