#### **Purpose**

The Brick Streets and Sidewalks Policy aims to balance preservation of Lawrence's historic brick streets and sidewalks with the need for modern accessibility and infrastructure maintenance.

The policy was developed through a city-wide community engagement driven approach to understand the communities values, while adhering to engineering standards, asset management best practice, accessibility standards, and practical implementation strategies.

Within the policy you'll find design and construction standards, maintenance standards, and preservation guidelines for both brick sidewalks and brick streets.

## **Policy Development Process and History**

The Brick Streets and Sidewalks Policy was possible due to the culmination of years of community advocacy work and engineering standard review and considerations that came before it. The policy development process included 6-months of active community engagement and staff worktime, built off the foundation of successes and setbacks we as a community have learned from over the past 10+ years of work. This policy aims to balance a number of competing values and desires with the real-world fiscal implications associated with managing a historic asset.

The staff working group and steering committee collaborated on the Brick Streets and Sidewalks Policy and are confident this policy makes strides towards supporting a unique community where all people can live, work, learn, and play safely, sustainably, and in a place

that feels like home.
